KEY INDICATIONS

- Active detoxification or antimicrobial protocols

HOW IT WORKS

TACX (tincture of ACX) supports coordinated hepatic detoxification and immune resilience during periods of increased toxic burden. It reinforces antioxidant defense, epithelial integrity, and organ-level signaling to enhance metabolic processing and inflammatory buffering. By promoting balanced drainage and strengthening detoxification centers, it helps improve tolerance to cleansing protocols while supporting efficient transformation and elimination of environmental and endogenous stressors. Unlike lymphatic formulas, it targets toxin clearance rather than fluid movement.

CLINICAL PEARLS

- Use 7–14 days before antimicrobial protocols to help reduce detox intensity.
- Add **Ks – Kidney S** when signs of poor renal clearance exist.
- Add **LymphGenic** when fluid congestion accompanies detox reactions.
- Therapeutic dosing recommended during active detox. Once reactions subside, reduce to maintenance dosing. Discontinue after detox and symptoms have stabilized.
